## SENIOR GAMES REPORT Joan Campbell, Senior Games Liaison

There is not much to add to the July report on Senior Games as far as qualifying meets and the scheduled State Senior Games to be held at the Long Center December 3-4, which will qualify Florida participants to compete at the National Senior Games in Birmingham, AL. The swimming events at these games will be from June 4 through 10th, and will contain the added events of the 200 butterfly and 400 IM. First through 4th place athletes who meet the minimum performance standards will qualify for the 2017 National Senior Games. These standards are posted on floridaseniorgames.com and nsga.com.

Some of the local qualifying meets in the state of Florida are Recognized by USMS. Because they require registering and must meet certain USMS standards, many of our local meets do not wish to be Recognized. This means that the participants qualify for the State meet but their times do not count for Top Ten for USMS. Information on local qualifying meets are posted on games@flasports.com

At the Annual USAS Convention in Atlanta held last month, a fee of \$100.00 per recognized meet was set by the House of Delegates. This fee will be charged to the LMSC for each meet

requesting USMS Recognition. It has been difficult to get local meets to request Recognition qualification as is, without fees. I would suggest that the LMSC pay the Recognition Fee in these instances and not pass on the cost to the Local Games. I suspect that if we do not the Games involved will not request Recognition. The number of games are not that many. I voiced objection to this fee, just so you know. Recognized meets are not insured by USMS and the only advantage is the use of the brand name. In many small LMSC's this is going to cut back on an excellent recruiting tool for USMS.

# 2016 Annual Report From your FL LMSC Registrar, Meredith Moore

As of October 23rd, we had 2709 swimmers registered in the FL LMSC for 2016 That represents about a 9% increase over 2015's final October figure of 2417.

\*1,674 were registered in 2015 (62%)

\*222 were registered anytime between 1988-2014 (8%)

\*823 were brand new members (30%)

52% are male, 48% are female.

98.5% of registrations were done online; 1.5% by paper.

So far, the FL LMSC had 317 Late Season registrations (Aug 1 - Oct 31). 194 (61%) opted for the "End of Year" plus 2017 membership and 123 (39%) opted for just the End of Year membership.

We had a total of 62 Clubs registered in 2016; 62 Clubs in 2015.

We had many new Clubs register this year:

We had 4 active Workout Groups of FACT: CLCF, HLJF, SPCF, VASF.

1 active Workout Group of SCSF: AWTC Club registration for 2017 started on October 1st. So far, 29 Clubs have registered for 2017. All Clubs MUST be registered by October 31st.

2017 swimmer registration begins on November 1st. Clubs must be registered in order for swimmers to register for a particular Club. We have around 33 Clubs that still need to register for 2017. Also, a Parent Club must register before any Workout Group can register with a parent Club.

I look forward to working to working with our Board, the FL LMSC, USMS and our Club Reps and swimmers in 2017. Thank you all again for for all your support and the opportunity to be your FL LMSC Registrar.
