TOP TEN AND RECORDS REPORT by Margie Hutinger

The list of meets that I submitted for Top Ten included four senior meets (Gainesville, Stuart, State Championships and Polk Co.), two development meets at St. Pete, two requested USA meets. three large meets (CATM, SPM & IRCC) and relays and splits requested from Y Nationals. In addition, for the FL Top 5 and records, I added Sr. Nationals (28 best swims); request for Charlottesville, NC (6 best swims); YMCA Nationals (340 best swims) and SCY Nationals (93 best swims). The USMS Top Ten booklet will be published in August.

I feel it is important to recognize the swimmers' best efforts, so I utilized my extra volunteer hours to include the three National meets. I wasn't able to include any record updates in recent LMSC newsletters, so I posted ALL the FL LMSC records (SCY, LCM, SCM, One Hour Postal and 5K/10K) at the St. Pete, July meet. As this was the only FL LMSC large meet this summer, it provided an excellent opportunity for swimmers to view their accomplishments and set goals for upcoming courses, an essential aspect of a competitive program. I was disappointed that my efforts to acknowledge the outstanding FL LMSC swimmers were negated when this bulletin board was selected, in lieu of other empty walls, to post the final results. To insure that this will not be repeated, the Florida Mavericks will donate a portable display which will be available at future meets.

Included in this issue are the SCM and One Hour Postal records. Gertie Perry (DST) once again receives the animal award for swimming all 18 SCM events (she did the same last year in SCY). She included a trip to Coral Springs to achieve her goal. Fifty-one individual women's and 7 relay records were broken, 58 individual men's and 4 relay records, plus 4 mixed relay records. It was good to see Rogers Holmes (HLJ) back in the water at the

Orlando meet, where he broke records in all 10 events. Cathy Shonkwiler (ORLM) set the pace for the women, with 9 records.

Alex Ramirez Miller came in 1st in the 200 back and 2nd in the 50, 200 and 100 free.

The 2.4 Hurricane swim at St Pete saw ideal conditions for championship swims by Nancy Durstein and Kim Thinel, with Elliott Schofield, age 80 and former All-American in open water swims, trying out his bionic hips - they worked.

Don Puchalski and Joan Campbell traveled to Hawaii for the USMS SCY Nationals. Joan captured the gold in the 1650 free and 200 back, silver in the 500 free and bronze in the 200 fly, 200 IM and 200 free. The St Pete Long Course Championships set the pace for a good group of CATM. The group took 3rd place visiting team honors with 670 points; women 2nd and men 5th (visiting team). High point awards were: Karen Gardner (1), Nancy Durstein (1), Joan Campbell (2), Alex Ramirez-Miller (3), Elliott Schofield (1) and Bob Lavanture (3). Good effort by all!! Results of all the great swims are posted on the web site.

Our new Web site is up and running smoothly thanks to help from Dick Brewer and the CAT team.

Top Ten preliminary times are out and Don Puchalski is listed 7 times, Joan Campbell in 11 events and Nancy Durstein in 10 events. Not too shabby!! SCY Nationals in Honolulu

Two Mavericks were among the 1,100 Masters who enjoyed "Hangin' Loose" in Hawaii.

Florence Carr, 75-79, set a National record in the 50 free, by lowering her record of 34.78 to an amazing 34.10. Her other wins came in the 100 and 200 free, 50 breast, 50 fly and 100 Individual Medley. In the May/June issue of SWIM Magazine, Carr was featured as one of the six fastest women in 2001. The USMS President presented her with a trophy to recognize her outstanding accomplishments. James Christie, 30-34, competing in only his 2nd Masters

meet, placed 7th in the 50 back.

St. Pete Masters LC Championships On July 12-14, seventeen Mavericks competed at the meet in St. Pete.



One of the highlights was the National record swim of our women's relay team in the 320+ age group (above). Kay Schimpf, Gertrud Zint, June Reynolds and Florence Carr swam the relay in 3:46.42 (which eclipsed the old record of 3:49.73). Another highlight was that we outswam the other 23 visiting teams to capture the women's, men's and combined division titles! The award was a donation to a charity of choice and we selected a memorial scholarship to benefit the Asphalt Green Youth Swim Program, in memory of two Masters swimmers who were killed in the twin towers on 9/11.

High point winners included Jean Allen, Patricia Tullman, Reynolds, Zint, Matt Watkins, Frank Tillotson and Robert Williams. 2nd places were earned by Doris Prokopi, Carr, Schimpf and James Browne while 3rd places went to Rosie Vijil, Ruth Hoskinson and Charles Weatherbee. Other point getters included Flavia Zappa, James Christie and Carole Dirksmeyer-Nichols.

2-Mile Cable National Championships

On July 13, Peggy Hughes traveled to Charlottesville, VA to compete in this meet. She won her 80-84 age group, with a winning time of 2 hours, 38 minutes and 46.20 seconds.

She also broke a Florida LMSC record in the 200 IM Linda Felton (50-54) also had a great meet. She placed in the top ten in all her events except one. Her meet was highlighted by a third place finish in the 50 breast. She swam all best times at the meet. 

Following is a newspaper article about the NY Marathon Swim:

Hard-Core Open-Water Swimmers Race Around Manhattan

Not even race instructions warning swimmers of areas with "whirlpool-like conditions hazardous to even small boats" and a dangerous passage through an area named "Hell's Gate" could deter 21 restless swimmers from entering New York's East River on Sunday, June 23 to begin the 21st annual Manhattan Island marathon swim.

Nearly eight hours later, Emily Watts, 34, a mother of two from Millers, Md., emerged the winner of the 28.5-mile swim in 7 hours and 46 minutes, beating out the field of 13 other solo participants and seven relay teams.

Ron Collins, 40, from Clearwater, Fla., finished a close second in 8:00.26. The course record, set in 1995 by Shelly Taylor Smith, remains untouched at 5:45:25.

Heat and humidity prevailed at the 6:30 a.m. start, as the racers jumped off a platform at Battery Park into the calm 68-degree water and began stroking toward the Brooklyn Bridge.

For the next 8 to 14 hours, numerous friends, family and curious spectators watched the swimmers make their way around the island. The course consisted of a counter-clockwise route around Manhattan, going up the East and Harlem Rivers, around the tip of Manhattan and

down the Hudson River to the finish at Battery Park.

Boats and kayaks staffed with six-person support teams were responsible for supplying nourishment and guiding each swimmer under and around the numerous bridges and obstacles. Course literature warned of dangerous currents capable of sweeping swimmers into the sewage disposal plant, protruding piers, prison barges and floating planes taking off and landing during the swim.

The swim attracted athletes from seven states, spanning in ages from 20 to 54 years old and from varying occupations. Participants included Rachel Luch, 20, a student at M.I.T.; Thomas Schwartz, a

42 year-old Florida eye doctor; and Terry Laughlin, 51, the founder of the Total Immersion swimming camps. The screening process for racers included a 14-page questionnaire that required a swim resume, a written essay stating their reason for wanting to compete, completion of a four-hour swim and a physical exam.

Some simply wanted to finish a marathon swim: others want an extreme way to celebrate turning 40. Still others say their driving force was from the heart. The marathon swim was first attempted in 1981 by a New York entrepreneur and investment banker named Drury Gallagher, a former All-American swimmer at Fordham University. His motive was to bring a lasting memorial to his son, Drury Gallagher, Jr., who died in 1980 in an accident, and to promote the sport of swimming.

Technical Rule Changes to Conform to USA Swimming Rules Effective Date - June 1, 2002

In accordance with USMS rule 601.4.6B, the rules of competition within USMS have changed due to actions taken by the USA Swimming Rules Committee on or about June 1, 2002 and the USMS Rules Committee on June 28, 2002. The actions by USA Swimming were in response to a request for interpretation of the USMA Swimming rules in light of the current FINA rules.

Summary of Changes -

Backstroke: To permit the movement of toes and feet above the surface of the water after the start signal is given. Toes, however, may NOT be brought over the top of the gutter.

101.1.2 BACKSTROKE (page 13)

B - All courses - The swimmers shall line up in the water facing the starting end with both hands placed on the gutter or on the starting grips. Prior to starting signal, the swimmer's feet, including the toes, shall be placed under the surface of the water. Standing in or on the gutter or curling the toes over the lip of the gutter is not permitted at any time. A backstroke starting block may not be used.

Notice is given that a proposed amendment to the bylaws of the Florida LMSC will be voted on at the October 12, 2002, LMSC meeting.
