The meeting was called to order at 4:02 PM EDT.

WALK-ON Item: Cheryl made a motion to accept Zena Courtney as the fill Secretary position until next election cycle, second by Scott. All in favor, no one opposed. Motion passed.

1. APPROVAL OF THE LAST MEETING'S MINUTES

Minutes to be amended to add that the 2022 Capt. Ransom J. Arthur M.D. Award winning duo of Anna Lea & Jim Matysek were announced by Kyle Deery, Chief Marketing Officer for USMS. The award recognizes their many contributions to U.S. Masters Swimming and is USMS's most prestigious volunteer award. Motion by Christopher Rieder to approve the minutes as amended, second by Meegan, All in favor, no one opposed. Motion passed.

2. FINANCE REPORT (Terri Goodman)

Terri indicated that the bank account is in good shape. Anna Lea mentioned that this report is missing a check for \$4075 for reimbursement to 6 or 7 meet hosts for using online entry system, Motion by Anna Lea to approve the Finance report, second by Cindi, All in favor, no one opposed. Motion passed.

3. MEMBERSHIP REPORT (Cindi Wood)

Cindi provided an updated comparison of the Florida membership compared to the National membership numbers. Florida YTD as of 7/13/22 is 2250 versus National YTD of 49,995. The

Florida membership number is on its way to surpass the Florida 2021 Total Year number of 2413 members as well as the National 2021 Total Year number if 51,124 members.

Last Year from 1/1/21 to 7/13/21, we had 1261 members, this year from 1/1/22 to 7/13/22, we have 2250 members. Cindi also noted that the Florida LMSC makes up 4.5% of all USMS across the country

Motion by Bob Jennings to approve the report, second by Scott. All in favor, no one opposed. Motion passed.

4. CHAIR REPORTS:

A. OFFICIALS (Nancy Kryka)

Nancy provided updates to original proposal for badges and official shirts. It was clarified that the budget allows official shirts will be distributed 2x/year. It was also recommended to use white shirt and the USMS badges for ease of reuse by the receiving officials. Nancy also requested funding for a coach's clinic focused in Central Florida. A motion was made by Scott Bay to reimburse reasonable and customary expenses for the clinic attendees, second by Christopher Reider. All in favor, no one opposed. Motion passed. Goal is to have clinic within the next 6 months, especially in preparation for next year's Spring Nationals in Sarasota. Cindi Wood also offered to help Nancy. Feedback is that the gift cards to the volunteers have been appreciated.

- B. SANCTIONS & TOP 10 REPORT (Anna Lea Matysek)
 There are 5 upcoming meets left in 2022, 4 Sanctioned, 1 Recognized. There are 16 potential national records that were submitted to USMS.
- C. WEBMASTER (Meegan Wilson) Meegan proposed that the Florida LMSC offer to host a one page website for clubs who do not have, or cannot afford a website. She created a website for F.A.C.T. as an example. The board voted in favor of the proposal.
- D. *NEWSLETTER* (Shelia Carpenter-can Dijk) The next newsletter article submission date is 25 July 2022. It was confirmed that the next submission date was listed in May newsletter.
- E. RECORDS (Nancy Kryka) The last update to FL LMSC records were SCM and records were posted to the website Apr 2022. SCY records are planned to be updated Aug 20

4. OLD BUSINESS

--Convention: the USMS rules were reviewed, and it was agreed that the FL LMSC is awarded 6 delegates for Convention in Denver on 15-16 September. A motion was made by Nancy to select: Cheryl Kupan, Jim and Anna Lea Matysek, Cindi Wood, Joan Campbell and Scott Bay to attend Conference, second by Scott Bay. All in favor, no one opposed. Motion passed

5. NEW BUSINESS

--Anna Lea presented a request for funds on behalf of Sarasota Sharks for the 2023 U.S. Masters Swimming Summer National Championship meet. This five-day meet is scheduled for August 2-6, 2023. Based on the precedent set by the 2013 and 2018 meets, they are requesting a grant amount of up to \$15,000 to be used to help cover costs in: rented shade structures for the pool deck, additional water dispensers and costs related to officials and volunteers (e.g. air conditioned VIP tent), Shade structures will benefit all attendees, both swim meet participants as well as officials and volunteers. Board requested

more specific numbers before dollar amount is approved. It was also noted that reliable timers are best found via donation to non-profit groups.

-- Board Elections: Cheryl will research the details and timing of the Board Election Nominations per the bylaws and notify the Board via email. Each current Board member are to let Cheryl know ASAP if they'd like to stay on the Board.

The next FL LMSC Board meeting will be held in October via Zoom.

The Deflector style is totally comfortable in the Florida heat. The Tamiami style is a lighter fishermen's style and is more comfortable in the Florida heat than the current Sarasota style. All these choices are long sleeve and SPF. Officials in CA and HI according to Teri White have Hawaiian print shirts, so this proposal would be a acceptable choice.



Florida LMSC Officials Gift Card Process

May 2022

- 1. The Florida LMSC meet must be Sanctioned and posted on the Southeast Zone website.
- 2. A non-fee gift card such as Publix will be purchased for Meet Officials and Referees only, not for Meet Directors or those running the timing system.
- 3. A \$25 gift card will be given for each day an Official/Referee works.
- 4. Two weeks before the meet, either the Officials Chair, or a designated LMSC Volunteer contacts either the Head Referee or Meet Director to find out how many Officials they expect, obtain a list of names of the Officials and determine how many days each will work.
- 5. The Officials Chair will designate a Florida LMSC volunteer, preferably a Florida LMSC Officer, to purchase the gift cards and send a Florida LMSC reimbursement form with receipts to the Florida Treasurer for 100% reimbursement.
- 6. The gift cards will be included in an official Florida LMSC thank you card with envelope to hand to the Head Referee or to each Official.
- 7. Each Official will receive the card on the last day that they work.
- 8. Any leftover gift cards and thank you cards will be used for future meets and managed by the Officials Chair.

OFFICIALS SHIRT PROPOSED PROCEDURE for the FL LMSC 4-15-2022

- 1) The Officials Chair or LMSC Volunteer will maintain a list of USMS-certified and USA-certified officials who have been given an embroidered shirt by the Florida LMSC.
- 2) Twice a year, in April and October, the Officials Chair or LMSC Volunteer will create a list of USMS-certified and USA-S-certified officials who officiated at a USMS-sanctioned meet during the previous six months, and who HAVE NOT been previously given an officials shirt.
- 3) The Officials Chair or LMSC Volunteer will obtain sizes from each of those officials.
- 3) The Officials Chair or LMSC Volunteer will obtain quotes for:
- a) the itemized cost for the shirts plus any shipping and handling charges, and
- b) the cost to have each shirt embroidered
- 4) The Officials Chair or LMSC Volunteer will submit the quotes, along with the list of names of the eligible officials, to the Treasurer and Chair of the Florida LMSC
- 5) Upon approval, the Officials Chair or LMSC Volunteer will order the shirts and specify that they be shipped/delivered to Royal Tees in Sarasota (embroidery vendor) to be embroidered
- 6) The Officials Chair or LMSC Volunteer will notify the embroidery vendor to expect the shirts (quantity and estimated delivery date)
- 7) Upon completion of embroidery, the Officials Chair or LMSC Volunteer will pick up the shirts from the embroidery vendor
- 8) The Officials Chair/Sanctions Chair/Chair or LMSC Volunteer will deliver the shirts to the officials by hand delivery if possible or shipping. If shipping, then shipping receipts should be saved and submitted to the LMSC for reimbursement and the shipping charges would have to be economical, in other words no overnight or expedited delivery). *It is most important to be sure to communicate the shirt is from the FL LMSC!*
- 9) The Officials Chair or LMSC Volunteer (the person who maintains the list of all officials who have received shirts) will submit an updated, full list of officials who have received shirts, including the dates they were given a shirt and the sizes, to the LMSC Board after the latest batch of shirts has been distributed.



Request for Funds

To be included in the 2023 Florida LMSC Budget July 13, 2022

The Sarasota Sharks, Inc., and the Selby Aquatic Center in Sarasota, Florida, have been awarded the bid to host the 2023 U.S. Masters Swimming Summer National Championship meet. This five-day meet is scheduled for August 2-6, 2023.

Hosting a USMS Nationals is a very exciting event for the Florida LMSC. The meet is expected to attract 1,000 to 1,300 swimmers and will present a rare opportunity for Florida LMSC members to compete in a USMS Nationals within their own LMSC. Two USMS Nationals were previously held in the Florida LMSC, in 1986 (Short Course, Fort Pierce) and 1997 (Long Course, Orlando). More recently, two large international long course meets were held in the LMSC. Those were the Pan American Masters Championships, held in 2013 in Sarasota and 2018 in Orlando.

The requirements for hosting a Nationals meet are extensive and costly. We are writing to the Florida LMSC with the request to provide a grant, similar to what was provided to the PanAms meets in 2013 and 2018, to help cover the costs of hosting this meet.

In 2013, the Florida LMSC provided **\$9,217** to the PanAms meet host to help cover costs for a social and general meet expenses. In 2018, the Florida LMSC provided **\$9,000** to the PanAms meet to cover general meet expenses.

Based on the precedent set by the 2013 and 2018 meets, we are requesting a grant amount of up to \$15,000 to the 2023 USMS Summer Nationals meet host. This grant will be used to help cover costs in three general categories: (1) rented shade structures for the pool deck and additional water dispensers, (2) costs related to officials, and (3) costs related to volunteers. Shade structures will benefit all attendees, both swim meet participants as well as officials and volunteers. The host for a Nationals meet is required to provide lodging and food for officials; we may also consider providing them with personal cooling fans or towels. Past Nationals meet directors have offered stipends to groups who bring enough timers for a half-day meet shift, and we intend to follow this model. It will also be necessary to provide food and drinks to volunteers. The Florida LMSC's financial support will significantly help us provide these necessities.

[Note: Our request above is in lieu of the LMSC's current policies in place for reimbursement of online entry costs to the meet host (currently \$5 per entrant) and officials gift cards (currently \$25 per official per day), as those costs are built into the contract between us (the meet hosts) and USMS.]

The Florida LMSC provides strong financial support for all sanctioned meets held in the LMSC, and provided exceptional support for the past two PanAms meets. Costs for food, lodging, and equipment have risen dramatically over the past several years and Nationals meet hosts are contractually obligated to shoulder significant expenses for the meets. We respectfully submit this request for up to a \$15,000 grant, as we feel it is a reasonable request based on past precedent and cost increases over the past five years.
